^{*} Two cities recanted their ordinances: Omaha, Texas and Mason, Ohio. The City Council of Omaha, Texas repealed their ordinance in exchange for a non-binding resolution on October 14, 2019. They did so upon the advice of their City Attorney after the ACLU filed an open records request. Omaha is the only city to have recanted their ordinance after being intimidated by the ACLU's open records request. The City Council of Mason, Ohio repealed their ordinance on December 13, 2021 after new leadership, openly against the ordinance, were elected to the Mason City Council in the November 2, 2021 election.

The enforcement date for all of the "de facto abortion ban" ordinances were immediate except for Danville, Illinois which contains a delayed enforcement date.
